## Education

As owner of Archaeological Research and Supply Company from 2004 to present, I have managed hundreds of contracts from inception to fruition relating both to prehistoric and historic archaeology for a period of 15 years. Created the Tribal Historic Preservation Office at the Bear River Band of Rohnerville Rancheria. Established relationships with federal and state agencies including creating memorandum of agreement, programmatic agreements, contract agreements, and consultation protocol, specifically with regard to the treatment of cultural resources throughout northern California. These treatment agreements serve as templates for federal agencies and tribal governments throughout the nation. Represented tribal interests at State Department to develop the United Nations Declaration of Indigenous Rights. Appointed tribal representative to the Tribal Nations Conference by two tribes for three consecutive years. Tribal representative for the Marine Life Protection Act negotiations with the State of California. West Coast Governors Alliance tribal representative from Northern California. One of three west coast tribal delegates appointed to the National Ocean Policy working group working directly with the White House representatives to develop national policy. Cultural resource and archaeological project management varying in scope from small surveys to large scale excavations. Project consultations and policy development at local to international levels.

**Consultation:** Twenty years of experience working with and for tribes across the nation. Developed consultation policy regionally, at the State level working with California State Office of Historic Preservation. At the national level, consulted with the Marine Life Protection Act working group, Advisory Council on Historic Preservation, National Ocean Policy working group, and National Native American Graves and Repatriation Act office.

**Survey/Monitoring:** Surveys include small scale residential and commercial lot surveys, to Timber Harvest Plans, CalTrans highway surveys, railroad corridor surveys, fiber optic line surveys, site damage assessments, military base section surveys, and reservoir surveys (Lake Oroville and Shasta Lake), among many others. Over the past two years my company has conducted and reported on over 250 projects in Humboldt County.

**Testing/Mitigation:** Projects include the excavation of the Smith Creek site in Humboldt County in collaboration with PALCO, California State University Sacramento, and the Bear River Band of Rohnerville Rancheria. This project included the development of a scope of work and request for proposals, resulting in the test excavation of a site with over 50 house pits, with contribution to, review and approval of subsequent report. Large scale testing and data recovery projects as crew chief and director of dozens of projects throughout California, Oregon, and Nevada for CalTrans, various military bases, and FERC relicensing projects in association with multiple large archaeological consulting firms. Dozens of smaller scale test excavations within Humboldt County. Site damage assessments include large scale mitigation of inadvertently damaged sites to small scale assessments of lithic scatters.

**Reports:** Each survey, test, and excavation are associated with a regulatory report; all are on file with the Northwest Information Center at Sonoma State. All reports have been accepted and acknowledged as satisfying project requirements without revision upon first submission. Most recent works are recognized and accepted as the most contemporary archaeological research pertaining to early habitation of the northern California region.
