Overview:

Under supervision, Instructional Student Assistants (ISAs) in this classification perform teaching, grading and/or tutoring duties for the majority of work hours in a given appointment in a given academic department or equivalent administrative unit over the course of an academic term. The work may be performed on-campus or at an off-campus public agency or private non-profit organization under an agreement with a campus in the CSU system. Students applying for ISA positions must be admitted or registered as a CSU student. Academic Student Employees may not concurrently hold a faculty or staff position. Students with assignments in more than one student classification (i.e., Teaching Associate, Graduate Assistant, and Student Assistant) are restricted to working a maximum of 20 hours per week during the academic year and up to full-time during academic break periods. Job Duties:

Assisting instructor of record with grading and other duties as assigned for HED 400: Sound Mind-Sound Body course.

Job duties include:

- Attending lectures as required
- · Meeting in-person with instructor as needed to discuss grades/grading
- Maintaining online record of student participation
- Attending and helping proctor the midterm and final exams
- Grading multiple choice, T/F and fill-in-the-blank portions of exams
- Grading credit/no-credit assignments
- Keeping record of participation for in-class discussions/group-work
- · Monitoring and keep log of online student forum submissions

Workload will vary between 6 and 8 hours per week throughout the semester.

Minimum Qualifications for this Classification:

<u>Knowledge and Abilities:</u> Instructional Student Assistants must possess the ability to learn and perform assigned work; work cooperatively with faculty, staff, and other students; and accept responsibility. Completion of specific coursework may be required in order to teach, grade or tutor a course.

<u>Special Qualifications:</u> Admission or registration as an HSU student is required. On-Campus or Off-Campus Work-Study Instructional Student Assistants must meet the eligibility requirements of the Federal Work-Study Program, as determined by the campus' financial aid office.

Note: Exceptions to the minimum eligibility qualifications may be granted at the sole discretion of Humboldt State University.

Procedures for Notification:
Successful applicants will be notified in writing by the Department Chair. Positions are offered generally at the beginning of the spring semester.

A background check must be completed satisfactorily before any candidate can be offered a position that is designated as sensitive under CSU guidelines. The background check will include, at a minimum, a criminal records check. Certain positions may also require a credit check, motor vehicle report, and/or fingerprinting through Live Scan service.
