### NOTES:

- All rates include use of vessel, motor, fuel, and all state, federal and HSU required safety gear. **It is always up to the operator to make sure all required safety gear is on board.**
- **Rates apply to the following:**
  - All vessel usage for non-HSU purposes
  - Grant-funded University and HSU Sponsored Programs Foundation Projects.
  - Collaborative projects where the majority of the data are to be used by a non-HSU entity.
- Rates may not apply to field trips for HSU courses.
- **The above rates do not include the cost of an HSU truck to tow a vessel to a specific location.** Currently the cost is \$30.00 per day or \$1.25 per mile, whichever is greater. The driver of the truck must have a current state defensive driving card. Please check with HSU Plant Operations for more information on vehicle questions. (707) 826-3646.
- **There is a 3 hour minimum** on all rates, this may include setup, launching, cleaning and stowing of vessel and gear.
- **All operators must be authorized by HSU.** For more details or to become an operator please refer to the HSU Academic Boat Safety Policies and contact Steve Monk in the Office of Boating Safety at the above number.
- **Faculty or graduate students** who want to use a small boat for research but lack grant funding should contact the Director of the Marine Lab at (707) 826-3671 or Steve Monk in the Office of Boating Safety at (707) 826-3686 to discuss their situation.
- **Vessel requests and reservations must be made a minimum of 1 week prior to use date.** Please contact the HSU Marine Lab at (707) 826-3671, Steve Monk in the Office of Boating Safety at (707) 826-3686 or visit the HSU Marine Lab Website at <http://www.humboldt.edu/marinelab/> for reservation requests.
- **Cancellations** must be made **≥ 24 hours** prior to scheduled date of use. The user will be charged a fee of 3 hours if he fails to cancel the reservation prior to the 24 hour period. Exceptions to this are cancellations due to bad weather or other immediate, unforeseen events (e.g., crew illness). No vessel use charge will be imposed for trips that are called off due to adverse weather or sea conditions within the first part of the trip. Personnel and truck charges may still apply.

- Rates for technicians will be \$50.00 per hour
- Day rates are for on-water use up to 10 hours, with vessel reservation for 24 hours.
- For trips with operators that are longer than 8 hours an overtime charge may apply.
- For extended offshore trips in the twin engine vessels a fuel surcharge may apply.
