Out of the \$40,000 budgeted to distribute, the committee awarded \$39,630 in total funding, leaving a remaining balance of \$370. In addition to this remaining balance, there was a residual \$2,165 from last year's Incentives Program, totaling a remaining balance of \$2,535. The committee authorized Steve to offer a partial award of \$2,535 to Ronnie Swartz (Social Work). In the case that Ronnie declines the award, the remaining amount will be offered to Julie Alderson (Art) for summer salary.

The committee expressed interest in viewing the success rates of previously funded Incentive Programs Awards from prior years. Steve has this data available and will provide this information at the next SPF Incentives Committee meeting.
