Safety Recall!

- T. C. Comet provided insight into a Hazardous Material spill incident in regards to a transport bus released a large amount of oil onto HSU and Arcata city property. The bus contacted a parking lot fixture, which punctured the oil pan of the bus. The response to the incident was responded to by the city and maintenance personnel for clean-up and retrieval of oil to a storm drain.
- Donn Peterson (UPD) discussed the lighting for walkways and parking lots on campus for safety and security. T. C. Comet (Facilities) informed the committee that there is an Energy Analyst who is looking at spots to identify as concerns or sustainable energy sources.
- <u>Smoking and Tobacco Free Environment Systemwide Policy</u> information is available on the Risk Management website. Depending on the situation, UPD can provide support in the area of inappropriate behavior, negatively affecting workplace air quality, or repeat offenders in regards to smoking on campus.
- Ron Rudebock stated Dining Services is having Alliant Insurance provide a "new set of eyes" to inspect their facilities and processes in Dining over an upcoming weekend.
